Whereas, the State of Goa currently does not have formal guidelines to regulate the trade or business of supply, installation, and certification of fire protection, fire prevention, and firefighting equipment;

And whereas, it is imperative that such critical life safety systems be installed, maintained, and certified only by qualified professionals to ensure adherence to safety standards;

Now, therefore, the Government of Goa hereby prescribes the following guidelines for the empanelment, licensing, and regulation of Licensed Agencies engaged in third-party audits, installation, and certification of

fire prevention and protection systems for low-risk and high-risk buildings in the State of Goa as defined in Notification 21/1/TCP/2020/GLDBCR/489 under the Goa Land Development and Building Construction (Amendment) Regulations, 2022 published in the Official Gazette, Series I No. 1 dated 07-04-2022.

1) Authorization of Licensed Agencies

- a) No person or entity other than a Licensed Agency shall carry out the installation, certification, or auditing of fire prevention and life safety measures in any premises or building.
- b) No individual or agency shall issue an audit certificate pertaining to fire safety compliance unless the systems are genuinely compliant, functional, and well-maintained

2) Power to Grant License to act as Licensed Agency

- a) The Director, Fire and Emergency Services, Government of Goa may grant any person or association of persons as he thinks fit, a licensee to act as a Licensed Agency for the purposes of conducting Fire Audit and installation of Fire Prevention and Protection Systems.
- b) Any person intending to act as Licensed Agency to conduct third-party inspection, shall apply to the Director, Directorate of Fire and Emergency Services, Government of Goa, in the prescribed form (Annexure-I) for grant or renewal of such license. The application shall be made online on the State Single Window System.
- c) On receipt of such application, the Director, Directorate of Fire and Emergency Services, Government of Goa, may, after holding such inquiry as he deems fit, either grant the license in the prescribed form (Annexure-II) for initial period of three years or renew the same for a like period or, for reasons to be recorded in writing, by order refuse to grant or renew the license.
- d) Where the Director, Directorate of Fire and Emergency Services, Government of Goa, has reason to believe that any person to whom a license has been granted and who failed to comply with the conditions of the license or is unfit by reason of incompetency, misconduct or any other grave reasons, the Director, Directorate of Fire and Emergency Services, Government of Goa may, after giving to the person a reasonable opportunity to show-cause, for reasons to be recorded in writing, by order suspend or cancel the license (Annexure -III).
- e) The Directorate of Fire and Emergency Services (DFES) shall develop and publish a comprehensive Manual/Standard Operating Procedure (SOP) to guide third-party Licensed Agencies in the uniform and effective conduct of fire safety site inspections. This manual shall cover inspection protocols, reporting formats, compliance checklists, and other operational procedures.

3) Eligibility criteria for Licensed Agency

No person or entity shall be granted a license to act as a licensed agency unless they meet the following criteria:

- a) At-least any of the following qualifications, namely:
 - i) a Degree or Advanced Diploma or Diploma in Fire Engineering awarded by the National Fire Service College, Ministry of Home Affairs, Government of India, or
 - ii) Fellow of Fire Engineering of the Institution of Fire Engineer (U.K.) or M.I. Fire (U.K.) or A.M.I.F.E. India, Graduateship Examination of the Institution of Fire Engineer (U.K.) or the Institution of Fire Engineers (India) and;
 - iii) having 3 years post qualification experience in a Fire Service established under law in a position not less than the rank of a Station Fire Officer or equivalent: or in the field of Fire

Protection and engineering including design, installation, commissioning and maintenance of Fire safety systems viz., automatic sprinkler system, automatic detection and alarm system, Fire Hydrant System, Manually Operated Fire Alarm system, wet riser/down comer system, Fire Pumps, Smoke management system's etc.

b) or

- i) a Degree or Diploma in Mechanical or Electrical or Chemical or Civil Engineering from a recognized university; and
- ii) experience in executing fire prevention and fire protection system, in high rise buildings/non high rise buildings/industries as laid down in the National Building Code of India, 2016 or the code published by the National Fire Protection Association (NFPA, USA) 2008 as amended from time to time, or

In case of (b) above, has in his employment for the purpose of execution and supervision of the work relating to fire protection and life safety measures in a building or a project, an officer or supervisory officer holding any of the qualifications mentioned in clause (a), so however that, a degree or diploma in Fire Engineering or any other qualifications in relation to fire protection, prevention and safety measures specified therein shall be an essential qualification.

- c) Financial Solvency: Must hold a solvency certificate for an amount as may be specified by the Director with Government approval.
- d) Technical Experience: Must have completed relevant projects within the last 3 years.
- e) Infrastructure: Must possess required tools, machinery, and equipment in relation to fire prevention and fire protection systems.
- f) Legal Standing: Must not be blacklisted by any Government or public agency.

4) Application process and fees

- a) Application shall be submitted online in format provided (Annexure I) on the State Single Window System.
- b) The prescribed fee and solvency threshold shall depend on jurisdiction as follows:

- c) Required documents as may be specified by the Director, Directorate of Fire and Emergency Services, shall include the following:
 - i) Solvency certificate
 - ii) Partnership deep/MoA/Proprietor affidavit
 - iii) Chattered Accountant certificate
 - iv) Qualification of key personnel
 - v) Passport photo of signatories
 - vi) GST Registration Certificate
 - vii) Affidavit for non-blacklisting.

5) Registration on State Single Window System

All empanelled third-party Licensed Agencies shall mandatorily register on the State Single Window System (SSWS) to enable digital integration of approval, inspection, and certification processes. The registration shall facilitate:

- a) Online assignment of inspection.
- b) Upload of reports and compliance data.
- c) Status tracking for stakeholders.
- d) Online dashboard for third-party agencies to ensure efficiency in timely inspections.
- 6) Online dashboard for third-party inspections
 - a) The State shall develop a real-time online dashboard integrated within the State Single Window System to monitor the inspections conducted by third-party Licensed Agencies.
 - b) The dashboard shall be made publicly accessible and shall display key metrics including the number of inspections conducted, types of buildings audited, status of compliance and performance history of each licensed agency.

7) License conditions

- a) The license shall be:
 - i) Non-transferable
 - ii) Valid for 1 year (renewable)
 - iii) Subject to cancellation for non-compliance
 - iv) Renewable, if so desired, one month prior to expiry.
- b) Any change in key personnel or registered address shall be immediately communicated to the DFES.
- c) All ongoing or completed work shall remain open for random inspection by DFES or its authorized officers.

8) Renewal of License

a) Renewal applications must be submitted before expiry, with the original registration fee and supporting documents as specified in Section 4, sub-section (c).

9) Enforcement and Penalties

The Director, DFES, reserves the right to suspend or cancel licenses of agencies in case of:

- a) Non-compliance with prescribed standards or misconduct
- b) Submission of false certificates
- c) Negligence or malpractice

Due process shall be followed, including issuance of a show-cause notice in the format prescribed (Annexure III) and opportunity to be heard.

10) Training and Certification of Fire Safety Officers.

To ensure quality control and technical proficiency, the Directorate of Fire and Emergency Services shall:

- a) Conduct mandatory training and certification programs for Fire Safety Officers employed by third-party agencies
- b) Issue certificates of competency valid for 3 years
- c) Maintain a public register of certified officers

- 1. Short title and commencement.— (1) These rules may be called the Goa Factories (Eighteenth Amendment) Rules, 2025.
