Whereas, the Government Notification No. 41/1/2022/PG(Notification)/235 dated 03.11.2022 published in the Extraordinary, Series II No. 31, dated 03.11.2022 has notified various public services rendered by the Directorate

of Fire and Emergency Services under the Goa (Right of Citizens to Time-bound Delivery of Public Services) Act, 2013 (Goa Act 19 of 2013).

And whereas, the No Objection Certificate issued by the Directorate of Fire and Emergency Services to various occupancies is valid for a period of one year and to be renewed every year.

And whereas, the Government in order to streamline the procedure of renewal of NOC in respect of all Public Services mentioned in the Notification No. 41/1/2022/PG(Notification)/235, dated 03.11.2022 published in the Extraordinary, Series II No. 31, dated 03.11.2022 has decided to relax the provision of renewal of No Objection Certificate from the Directorate of Fire and Emergency Services and extend the renewal period from one year to five years from the date of issue of No Objection Certificate. The said renewal shall be applicable for both low-risk and high-risk buildings as defined in Notification 21/1/TCP/2020/GLDBCR/489 under the Goa Land Development and Building Construction (Amendment) Regulations, 2022 published in the Official Gazette, Series 1 No. 1 dated 07.04.2022.

Now therefore, the Government is pleased to issue the following directions as regards to issue and renewal of No Objection Certificate to the all Public Services in the State of Goa namely:-

- 1. The owner/occupier of the premises shall continue to obtain a No Objection Certificate (NOC) from the Directorate of Fire and Emergency Services, as required under applicable fire and safety regulations.
- 2. The validity of No Objection Certificate shall be period of five (5) years, subject to the following condition:
 - a. The concerned owner/occupier must submit a self-declaration in the prescribed Format (Annexure–A) on the stamp paper of ₹100, annually stating that the Fire Protection Arrangements installed in the premises are regularly maintained, are fully functional, and can be operated in case of an emergency.
 - b. Upon completion of five-year period, the NOC may be renewed provided the Fire Protection Systems are inspected and found to be in proper working condition by the competent authority.
- 3. (a) The Designated Officer under the Goa (Right of Citizens to Time-bound Delivery of Public Services) Act, 2013 (Goa Act 19 of 2013), shall be empowered to conduct the Fire Prevention Inspection at any time during the calendar year to evaluate the efficacy of the installed Fire Protection Arrangement.
- (b) If the fire protection arrangements are found to be non-operational or not in compliance, the Designated Officers holds the authority to revoke the NOC, after giving a reasonable opportunity of hearing.

AWARD

(Delivered on this the 26th day of the month of May of the year 2025)

By Order dated 14/06/2018 bearing No. 28/24/2017-LAB/384, the Government of Goa in exercise of powers conferred by Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (Central Act of 14 of 1947), hereinafter referred to as the "said Act"), the existing dispute between the Management of M/s Country Club de Goa, Anjuna, Bardez, Goa and its workmen represented by Goa Trade & Commercial Workers,has referred the following dispute for adjudication to the Industrial Tribunal of Goa at Panaji-Goa, constituted under Section 7-A of the said Act.

SCHEDULE

1. "Whether thefollowing demands raised by the Goa Trade and Commercial Workers' Union before the management of M/s Country Club de Goa, Anjuna, Bardez, Goa are legal and justified?

CHARTER OF DEMANDS

1. Grade/Flat-Rise in Basic-Salary and Pay-Scales:

That each Workperson be graded appropriately as per the nature of work performed by them and be paid a sum of Rs.2500/- as a Flat-Rise over and above the existing "Basic Salary" earned by him/her as on 31/12/2015. The "Basic Salary" of each workperson as on 31/12/2015 PLUS the Flat-Rise of Rs.2500/- per month be placed in the respective pay-scales given below and fitted in it at the appropriate stage in the Scale-Pay and paid to each worker w.e.f. 01/01/2016.

2. House Rent Allowance (HRA):

That w.e.f. 01/01/2016 each worker shall be paid sum of Rs.1500/- per month towards House Rent Allowance (HRA) over and above the existing H.R.A.

3. Fixed Dearness Allowance (FDA):

That w.e.f. 01/01/2016 each workperson shall be paid a sum of Rs.3000/- per month as Fixed Dearness Allowance (FDA) at base 5500 points All India Consumer Price Index (AAICPI) (1960=100).

4. Variable Dearness Allowance (VDA):

That w.e.f. 01/01/2016 each workperson shall be paid a Variable Dearness Allowance (VDA) at the rate of Rs.2/- per point over and above base (AAICPI) 5500 points (1960=100).

The Variable Dearness Allowance (VDA) be revised every quarter.

5. Conveyance Allowance:

That w.e.f. 01/01/2016 each workperson shall be paid an Additional Conveyance Allowance of Rs.1000/-per month.

6. Shift Allowance:

That w.e.f. 01/01/2016 each workperson shall be paid a Shift Allowance on the following basis:

| 7.00 a.m. | to | 4.00 p.m. | Rs.30/- per shift; |

| 8.00 a.m. | to | 5.00 p.m. | Rs.30/- per shift; |
| 9.00 a.m. | to | 6.00 p.m. | Rs.30/- per shift; |

| 3.00 p.m. | to | 12.00 p.m. | Rs.50/- per shift. |

7. Out-Door Food Allowance:

Whenever a workman is sent on out-door duty he/she shall be paid an Out-Door Food Allowance towards breakfast, lunch, dinner, tea and snacks on the following patters:

| Breakfast | Rs.35/- per day |
|--------------|----------------------|
| Lunch | Rs.100/- per day |
| Dinner | Rs.100/- per day |
| Tea & Snacks | Rs.35/- per day |

8. Leave Travel Allowance (LTA.):

That w.e.f. 01/01/2016 each workperson shall be paid Rs.6,000/- as Leave Travel Allowance (LTA) in the month of December every year.

9. **Overtime**:

That each employee shall be paid overtime at double the rate of wages with retrospective effect irrespective of his grade and designation. Whenever an employee is required to work on Sundays/Holidays and Weekly Off days, they shall be paid double the rate of wages with a paid compensatory-off which shall be allowed to be availed by an employee within 10-days of such work. In the event where an employee exceeds 16-hours of duty due to exigencies of work, he/she shall be paid overtime as above and shall be given a paid compensatory off, consequent to such work.

10. Leave Facilities:

All the workpersons shall be made eligible to the following Leave Facilities w.e.f. 01/01/2016.

(a) Privilege Leave: 30 days per annum with facility to accumulate upto 100 days and encash leave above 50 days.

(b) Casual Leave: 12 days per annum with a facility to accumulate upto 30 days or

with a facility to encash the balance Leave.

(c) Sick Leave: 10 days per annum with a facility to accumulate upto 30 days.

(d) Holidays: 12 days per annum to be finalized in the month of January, every

year between the Union and the Management.

The availment of leave ought to be discussed between the Parties. The present system of leave availment is most inconvenient to the workmen.

11. Rest Room And Lockers:

Proper Rest Room and Locker room shall be provided to the workmen with adequate facilities.

12. Interest Free Loan Facility:

Each worker ought to be made eligible to an Interest Free-Loan-Facility to the extent of Rs.50,000/- to be deducted in 25 equal installments.

13. Bonus:

That w.e.f. 01/01/2016 every workperson ought to be paid Bonus for every financial year @ 20% without any ceiling.

14. Festival Advances:

That each workperson be paid Rs.5,000/- as Festival Advance to be deducted in 10 equal installments at least 10 days prior to the following festival, every year.

- a) Ganesh Chaturthi festival
- b) Christmas festival
- c) Festival of Id.

15. Service Charge:

- a) All employees shall be paid 10% service charges per month on the gross sales in the Hotel.
- b) All service charges shall be distributed equally to all ranks-and-file.

16. Issuance of Letters:

The workmen shall be issued detailed letters of Appointment/Confirmation in service specifying his/her date of joining, confirmation in service, grade, etc.

17. Interim Releif:

Pending the finalization of all the above demands spelt-out herein, in this Charter of Demands, the Union/workmen demands that each workman who is on the pay roll of the Company be granted an amount of Rs.5500/- as an INTERIM RELIEF as the present salary and other emoluments paid to the workmen are meager and pathetic. This Interim Relief be adjusted from the final relief to be granted to the workmen effective from 01/01/2016.

18. Grievance Redressal System:

The grievance must be responded by the Management within 48 hours of registering them. The present grievance/redressal system operative in the company is extremely poor and outdated and unresponsive.

- 2. If the answer to issue No.(1) above is in the negative, then, to what relief the workmen are entitled?"
- 4. Considering the pleadings of both the Parties this Tribunal framed issues on 02/05/2019 at Exhibit 8. The issues reads as under:

ISSUES

1. Whether the Party I proves that the Charter of demands raised by it against the Party II are legal and justified?

- 2. Whether the Party II proves that the reference made by the Government is not maintainable?
- 3. What Relief? What Award?
- 5. The Party I in support of their case, examined their witness ShriRajendraMangueshkar. Along with the Affidavit-in-Evidence at Exhibit 12, ShriMangueshkar produced documents from Exhibit 13 Colly to Exhibit 22. This witness was cross-examined by the Advocate for the Party II and the Party I closed their evidence.
- 6. On behalf of Party II, witness ShriDudekulaHussainiwas examined. He produced his Affidavit-in-Evidence at Exhibit 28 and also produced on record the documents from Sr. No.29 to 34 Colly. This witness was cross-examined partly and the matter was adjourned for further cross-examination of the Party II witness at which time there came the proposal for settlement which was consented and accepted by both the Parties. Both the Parties were given liberty to compromise the matter amicably and accordingly exchanged the proposed drafts of settlement/compromise terms to each other. Finally, on 22/04/2025 both the Parties jointly filed terms of settlement along with the annexures at Exhibit 35 Colly.
- 7. The above application as well as the terms of settlement at Exh.35 Collyhave been signed by the Advocates appearing for both the Parties and have agreed upon the terms mentioned below:

The terms of Settlement are as follows:

- 1. It is agreed between the Parties that the legal heirs of the deceased Mr. Justine Fernandes shall be paid Leave Encashment amounting to Rs.33,976.00 (Rupees Thirty Three Thousand Nine Hundred and Seventy Six Only).
- 2. It is agreed between the Parties that the legal heirs of the deceased Mr. Justine Fernandes shall be paid gratuity and EPF which shall be paid by the Office of Life Insurance Corporation and EPFO and Corporation shall assist the legal heirs in claiming the said amount before the respective offices. Necessary process shall be initiated by the Corporation within 156 days.
- 3. In addition to the above, the Corporation agrees to pay the legal heirs of the deceased Mr. Justine Fernandes a sum of Rs.3,00,000/- (Rupees Three Lakhs Only), as ex-gratia in full and final settlement of all their claims.
- 4. Accordingly, the legal heirs of the deceased Mr. Justine Fernandes agrees not to pursue the dispute raised before the Industrial Tribunal under reference No. Apln.1/2018 in the matter of their termination from service or any dispute raised individually or through any Union before any Tribunal, court, Authority or Forum and treat the same as settled.
- 5. Further, the legal heirs of the deceased Mr. Justine Fernandes agrees that the deceased Mr. Justine Fernandes ceased to be in service of the Company and further agrees not to raise any industrial dispute in the matter of his termination before any Court/Authority/Forum, either individually or through any Union and if any such dispute has been at all raised, the same shall be treated as settled.
- 6. It is agreed between the Parties that this settlement shall be filed before the Industrial Tribunal in Appln. No. 01/2018 for an Award in terms of the present settlement.
- 8. I have gone through the application dated 04/04/2025 along with the Memorandum of Settlement at Exh. 35 Colly filed on record duly signed by both the Parties. The terms of settlement are acceptable to both the Parties which in my view, are just and fair to bring about harmony and industrial peace. As such the Settlement is accepted.

In view of above, I pass the following Order:

ORDER

(i) The reference at the instance of both the Parties stands disposed off in view of the Settlement arrived by both the Parties at Exhibit 35Colly.

- (ii) No order as to costs.
- (iii) Inform the Government accordingly.
