ORDER

1. The Appellant Mr. Sarvesh Dessai, resident of H. No. 7133-B, Salmona, Saligao, Bardez-Goa had filed Appeal dated 14.08.2025 against the Public Information Officer, Directorate of Fire & Emergency Services, St. Inez, Panaji Goa under Section 19 of the Right to Information Act, 2005 for not furnishing information sought vide application dated 19.06.2025.
2. The Appellant Mr. Sarvesh Dessai and Respondent Public Information Officer, Directorate of Fire & Emergency Services, Panaji Goa were requested to remain present in the office of the Appellant Authority for the hearing on 12.09.2025 at 15.30 hrs vide Notice No. DFES/CONF/94-XVII/2025-26/2912 dated 26.08.2025. The Appellant was failed to attend the hearing and Respondent was present for the hearing. The next date of hearing was fixed on 19.09.2025 at 15.30 hrs. vide Notice dated 16.09.2025, the Appellant was absent for the hearing and Respondent was present for the hearing. The 3rd hearing was fixed on 09.10.2025 at 15.30 hrs vide Notice dated 01.10.2025, the Appellant was absent for the hearing and Respondent was present for the hearing.

3. The Appellant is given the opportunities on 3 occasion, however the appellant was failed to attend the hearing on all the occasion. Hence the 1st Appellate Authority is of the opinion that the Respondent is not interested in the 1st Appeal. Hence the 1st appeal dated 14.08.2025 filed by Shri Sarvesh Dessai is disposed off without an order.

If the Appellant is not satisfied with the First Appellate Authority, he may prefer Second Appeal before the State Information Commission, Kamat Tower, Patto Plaza, Patto Centre, Panaji Goa.
