Sub:- Request of NOC/clearance from Directorate of Fire and Emergency Services.

Sir,

The National building Code, 2016 published by the Bureau of Indian Standards mandate fire and life safety requirements in respect of the following type of buildings:

- a) all high rise buildings; and
- b) special buildings, those are,
- hotel, educational, institutional, business, mercantile, industrial, storage, hazardous and mixed occupancies, where any of these buildings have floor area more than 500m2 on any one or more floors;
- educational buildings having height 9 m and above;
- institutional buildings having height 9 m and above;
- all assembly buildings;
- buildings, having area more than 300 m2 of incidental assembly occupancy on any floor; and
- buildings with two basements or more, or with one basement of area more than 500 m2.

The Goa Land Development and Building Construction Regulations also specify that the latest provisions of National Building Code has to be followed.

Instances have then brought to the notice that application for NOC/clearance from Directorate of Fire and Emergency Services are sought by the project proponents during the time of construction and not before commencement of the construction or before issue of construction licence. This is causing difficulty to the said Directorate in implanting the provisions as reported by the said Directorate on various occasion. As the fire and life safety is an important aspect which needs to be addressed with utmost importance, the District level/Taluka level offices of the Department and PDAs are being instructed to pulate specific condition mentioning clearly that NOC/clearance from the Directorate of Fire and Emergency Services shall be insisted before issuing the construction licence by the local bodies for the type of buildings listed at points a) & b) of this letter.

You are requested to sensioner the Commissioner/Chief Officers of the Corporation/Municipal Council and Societaries of Village Panchayats as the case may be for strict compliance of the staye.
